• **Deadline extensions:** In view of the immediate burdens for Ukrainian stu-

- amination periods in this winter semester, which have already been made considerably more flexible in the context of the Covid 19 pandemic, should also be made possible in view of the war in Ukraine.
 Fair granting of disadvantage compensation: The examination boards were
- asked to be as accommodating as possible when granting compensation for disadvantages (Nachteilsausgleiche). Mental health concerns of students should also be accepted as reasons.
 Hybrid courses in the summer semester of 2022: Ukrainian students at

Humboldt-Universität are currently asking whether they can also participate in

courses digitally. Despite plans for a largely face-to-face semester, which are

still in place, faculty and instructors have been asked to create hybrid formats for Ukrainian students. Solutions are currently being developed regarding the participation of refugee Ukrainian students in the regular course offerings. Language courses for Ukrainian refugees are also being planned.

Summer semester 2022

are continuing to pursue this goal. Unfortunately, due to the pending Senate resolution on the implementation of the nationwide opening plans we are not yet able to pre-

dict which conditions we will be facing for the summer semester.

Therefore, the 3G rule applies until further notice. Admission requirements for all members of the university are proof of vaccination or convalescence or proof of a negative test result, which must not be older than 24 hours, or 48 hours in the case of

PCR tests. The FFP2 mask requirement also remains in place.

We are currently working on making the 3G controls possible throughout the summer semester, if they should still be required then. You will of course receive more detailed information on this as soon as we have it.

Use of the self-chosen or lived name

As proof, only a digital copy of the DGTI supplementary ID card has to be attached. After registration, the lived name is used in all connected systems. This includes in particular the portal "AGNES", the teaching and learning management system

As of April 1, 2022, it will be possible to use the self-chosen or lived name in our

Moodle as well as the video conferencing services Zoom and Big Blue Button.

Last year, the Presidium already advocated the use of the self-chosen or lived name on documents with external impact as well. In addition to the comprehensive effect for the students concerned, this would also have enabled faster implementation. However, Berlin's Senate Administration continues to maintain its view that the use of the self-selected name on documents with external effect (enrollment certificates,
