## Distribution of final grades in Law (Staatsprüfung)

## 0421 Law

In order to achieve better comparability between various grading systems, the Humboldt-Universität zu Berlin follows the European Union regulations providing relative grades in the form of grade distribution tables<sup>1</sup>. For that reason, the HU Berlin uses a reference group selection based on the International Standard Classification of Education (ISCED)<sup>2</sup>. The data for ECTS grading tables are generated annually. The reference period includes three previous calendar years at the time of data collection respectively.

The ECTS grading table below shows the statistical distribution of final grades, the total number of passed final examinations in the period considered, and the average of the recorded final grades. Description of final grades is made according to the Regulation of the Federal Ministry of Justice on a grading scale for the First and Second Legal State Exam of 3 December 1981 in the currently valid version (Verordnung des Bundesministeriums der Justiz über eine Noten- und Punkteskala für die erste und zweite juristische Prüfung vom 3. Dezember 1981 (BGBl. I S. 1243) in der jeweils geltenden Fassung).

This document is valid for those graduates who completed their studies in 2024 by a Staatsprüfung.
